An important concern for the Amillennialist camp and our church:

Where is the Eye of the True Shepherd? Are the shepherds responsible for the welfare of the flock when it comes to guiding them in the right way so that they do not make covenants with false prophets and false shepherds, who have a well documented history of robbing the poor of their money, health, and their ability to take dominion (Gen. 1:18), to populate the earth through their children? John 10:10-15 would seem to say so, would it not?:

Scripture: The thief cometh not, but for to steal, and to kill, and to destroy: I am come that they might have life, and that they might have *it* more abundantly. **11**I am the good shepherd: the good shepherd giveth his life for the sheep. **12**But he that is an hireling, and not the shepherd, whose own the sheep are not, seeth the wolf coming, and leaveth the sheep, and fleeth: and the wolf catcheth them, and scattereth the sheep. **13**The hireling fleeth, because he is an hireling, and careth not for the sheep. **14**I am the good shepherd, and know my *sheep*, and am known of mine. **15**As the Father knoweth me, even so know I the Father: and I lay down my life for the sheep.

What is the Blind Eye of the False Shepherd? If the answer is yes, then as the true shepherds of the flock you and only you alone who are first responsible by example, will not shrug the responsibility to oversee the claims of the news media of those who in effect demand the church covenant with them through vaccination immune system hijacking as they commit crimes against humanity, robbing the church of the image of God and our children to be sacrificed by them in what amounts to a modern form of Baal worship under the guise of science so called. And to then warn the church as her shepherds and watchmen Ezekiel 33, 34.

Rather, the Bible indicates that and older women in the church (and Sunday school messages) are the appropriate resource for who should be used in this situation and in what way, Titus 2:3-5.

So Heavenly Minded To Be of No Earthly Good: Therefore, to reclaim the rightful office of a shepherd who cares for the sheep, what would logically be necessary first is unbiased research of all the News organizations, such as are found in the chart below, and of who may have Christian values or who gives way to Sodomites. (CNN is run by millionaire Sodomite Anchors who give medical advice and definition in the world.) To rightly define ALL things, Gen 2. [Not to mention prayer and the faith to simply trust God come what may without interventions that have been developed over the years typically through the process of unwitting human substitutes sacrificed for them.] Research will show that the chart I supplied is illogical and biased, Food Babe and Natural News have been suppressed by who owns the majority of the news networks and their advertisers, principally the pharmaceutical industry and military interests. And Scientific American is unscientific. In other words, the first thing one will need to learn in order to shepherd the flock in worldly matters is that there are two sides to news, one has principally to do with trying to research truth and the other has to do with easily dispelled deceptions, fallacious arguments driven by big money.
